New Bike Lanes along B&A Blvd!

Special thank you to the Old Frederick Road residents led by Laura Derringer for getting these bike lanes!!

What: The Anne Arundel County Department of Public Works was asked by concerned citizens to provide bike lanes along the section of B&A Blvd. We are taking this opportunity to inform the area residents and businesses of this pavement marking modification. You may already see some white paint marks on the road which outline where the bike lanes will be.

Where: B&A Blvd. from Old Frederick Rd. to Arnold Rd. northbound and southbound. Some on-street parking will remain on the west side between the fire station and the YWCA.

When: You can expect the permanent pavement markings and associated signing to be installed by the beginning of May.
